

**SHARE NOW CAR SHARING DRIVING CREDIT
PROMOTION
RULES OF PARTICIPATION**

This present Rules of Participation (hereinafter “**Rules**”) set forth the terms of participation in the promotion (hereinafter “**Promotion**”) to be held under the name “**SHARE NOW Balaton Sound**” in connection with Balaton Sound Festival 2022.

Organizer of the Promotion. The Promotion is organized by the organizer of Balaton Sound Festival 2022, Sziget Kulturális Menedzser Iroda Zártkörűen Működő Részvénytársaság (Hajógyári sziget, hrsz. 23796/58, 1033 Budapest, Hungary, Reg. No.: Cg. 01-10-049598, tax number: 26189905-2-44, hereinafter “**Sziget**”).

Term of the Promotion. The Promotion shall be held between June 3, 2022, and 23.59, July 3, 2022 (CET).

Description of the Promotion. The persons who purchased a presale ticket for Balaton Sound Festival 2022, by sending via email to kozpont@share-now.hu, the individual coupon code received at the purchase, until 23:59, June 29, 2022, shall automatically be entitled to 4000 SHARE NOW credit per each day of pre-booked package rental between June 29, 2022 and July 2, 2022, with the condition that the maximum available SHARE NOW credits shall be 16,000 (hereinafter, the “**Promotional Discount**”).

Participants of the Promotion. The natural persons shall automatically participate in the Promotion who purchase(d) pre-sale ticket for the Balaton Sound Festival 2022 online, in Sziget’s webshop accessible from <https://balatonsound.com> or any official ticket distributor. Only such a transaction shall be considered as a purchase which is closed by a payment transaction. Each ticket purchase entitles to participation in the Promotion with no regard to the number of tickets purchased.

Receipt of the Promotional Discount. Ticket purchaser eligible to the Promotional Discount will be sent via the voucher of the presale ticket the coupon code required for the use of the SHARE NOW credits. The Participant of the Game is entitled to use the code on the Share NOW website (https://www.share-now.com/hu/hu/budapest/?gclid=CjwKCAjwgr6TBhAGEiwA3aVuIYAZ_-AYV6xd53d5gLjn80CH9igE0yYulE9V2UeJMy28wJg3sO5mCBoC2g8QAvD_BwE) until 23.59, June 29, 2022 (CET). A code can only be used once. Sziget excludes its liability for any and all misuse of the code. The SHARE NOW credits may only be used in Hungary. Legal Characteristics of the Promotion. The Promotion shall be considered as a business promotion in the respect of the Promotional Discount. Sziget shall pay all taxes and contributions after the Promotional Discounts.

General provisions. The Promotion shall be held pursuant to these Rules. Participants shall accept the rules related to the Promotion as binding by purchasing a presale ticket. Sziget excludes its liability for all and any misuse.

Data processing. The email address used by the Participants of the Promotion in the Promotion will be processed by Sziget for the purpose of sending and enabling the use of the code required for the use of the Promotional Discount. Sziget only stores these data until the end of the Promotion. The legal basis for data processing is the participant's consent pursuant to Article 6 paragraph (1) a) of the 2016/679 regulation of European Parliament and Council (GDPR). Consent may be withdrawn at any time by sending an email to dpo@sziget.hu. Such withdrawal does not affect the lawfulness of processing based on consent before its withdrawal.

Pursuant to the GDPR, during the data processing, the participant may request access to the personal data and may request information about data processing (which will be provided by Sziget within no more than 1 month), may request rectification or erasure of personal data or the restriction of data processing.
