## **Heineken Balaton Sound - Caravan Camping Visitor Policy**

## DEAR CAMPER,

If you use the camping areas of Heineken Balaton Sound festival organised by Sziget Cultural Management Ltd. (Sziget), you have to comply with the mandatory rules of conduct of the camping areas.

- 1. Visitors are admitted to the camping area at the times and according to the conditions specified on their ticket.
- 2. One Visitor is only entitled to occupy an area of maximum 6 square meters.
- 3. Setting up shading tents or beer tents is prohibited.
- 4. Sziget asks Visitors to park their caravan or campervan exclusively at the designated areas, making sure, that they leave the escape routes, fire lanes and restricted areas free. If a Visitor fails to comply with this safety requirement, Sziget staff or the employees of the National Directorate General for Disaster Management is entitled to ask the Visitor to move his or her tent to a designated area. It is forbidden to park at the restricted areas.
- 5. Power consumption is allowed, so a device with a maximum power of 1000 W and 1 extension cord with a maximum length of 50 meters can be connected and divided into 6 parts. The connection point of an extension or distributor cannot be placed directly on the ground, and it is also necessary to ensure contact protection. If the connection is not appropriate, the Visitor must terminate the connection on the instruction of the Sziget staff.
- 6. For safety reasons it is prohibited to use your own air conditioner, electric stove, electric kettle, gas stove or fridge at the camping area. Exceptions to this rule may be made for rented equipment belonging to the accommodation or equipment installed in a caravan.
- 7. Entry in a vehicle to the camping areas is forbidden with the exception of a vehicle carrying out cleaning or maintenance, a vehicle that has the vehicle entry permit of the camp leader and the staff's motorbikes. Except caravans that may only park in the camping area with a valid caravan area ticket although, the vehicle towing it must leave the camping area immediately after parking the caravan.
- 8. Sziget draws attention to the fact that it is strictly forbidden to damage trees (for example breaking branches, nailing anything to the trees, cutting out trees).
- 9. Please do not disturb the peace of others by listening to loud music between 2am and 8am.
- 10. Sziget may not be held responsible in connection with the Visitor's objects that can be found at the camping area, therefore Sziget is not responsible for any damage or loss of the Visitor's property caused by another Visitor, or anyone else.
- 11. Any Visitor who causes damage to the facilities, equipment or infrastructure located at the camping area shall be liable for such damage.
- 12. The Visitor is obliged to notify the Camp reception of any failure of the equipment, about tort, and also about violation of this Camp Policy.
