### Park and Sound Parking lot

# Parking regulations (General Terms and Conditions)

The purpose of the Parking Regulations is to define the conditions of parking and the responsibilities of all parties - that is, the operator of the parking lot and the driver and/or passengers of the parked vehicle. Responsibilities and claims arising from violations of the Parking Regulations are valid even after leaving the parking lot.

The agreement is concluded between the operator and the customer purchasing the voucher regarding the outdoor parking. The agreement is established upon commencement of parking, as described below.

These Parking Regulations are governed by Hungarian law, without regard to conflict of laws.

#### General

1. The parking lot is operated by Sziget Cultural Management Ltd. (address: 1033 Budapest, Hajógyári-sziget, Hrsz.: 23796/58; tax number: 26189905-2-41). (Operator).

2. The Operator offers parking services in Zamárdi, in the area accessible from the crossing of Szent István út – Harcsa utca.

3. The parking lot can be accessed 0-24 hours between 07.02.2024. Tuesday, 2 p.m. - 07.07.2024. Sunday, 12 p.m.

4. The parking lot is located directly on the south side of Szent István út, accessible after the crossing of Szent István út – Harcsa utca.

5. Customer: visitor using the parking lot with a valid voucher.

6. Please watch our colleagues at the entrance of the parking lot. Vouchers are redeemed at the entrance of the parking lot.

7. You can enter the parking lot with a valid voucher. After redeeming the voucher and driving in, the parking card must be filled in with the necessary data and placed behind the windshield in a clearly visible place.

8. Validity of the voucher: 07.02.2024. Tuesday, from 2 p.m. - 07.07.2024 Sunday, until 12:00 p.m.

9. From the parking lot, you can walk to the Heineken Balaton Sound festival area and to the campsites.

10. During the Event, the car left in the parking lot is accessible.

11. The parking ticket entitles you to continuous entry during the specified period. After leaving the parking lot, you can return to the parking lot without buying another parking ticket.

12. Caravans / mobile homes may not use the parking lot.

13. The parking lot is not guarded. We are not responsible for the vehicles parked in the parking lot and the packages left in the vehicles.

# Traffic regulations

14. Traffic Rules apply within the parking lot. Customers must comply with these rules when entering the parking lot. The speed limit is 10 km/h within the parking area.

15. Customers are responsible for damage caused to parking lots and/or other parked vehicles. The Operator is not responsible for damages caused by the Customers to third parties.

16. Entry into the parking lot is controlled by the parking staff and, if necessary, they provide assistance with parking. Customers (drivers and passengers) may not block or impede the parking of other vehicles while parking or during getting in and out, moving luggages or leaving the parking lot.

17. Customers must keep their vehicles locked and take the keys with them. Operator does not store keys or documentation; as a result, the staff cannot move the cars under any circumstances. The Customer accepts the extent of the Operator's responsibility as determined by these Parking Regulations and the amount of the parking fee with respect to these conditions.

18. In case of a fire, natural disaster, terrorist attack or any other extraordinary event, when the operator does not have the means to protect property or personal safety, the instructions of the state or municipal authorities must be followed.

### Safety regulations

19. When leaving the parking lot, the rightful owner of the car shall be considered the person who has the keys to the car, unless his identity is clearly in doubt.

20. In case of loss of the key, the person who is listed as owner or operator in the vehicle's license is entitled to receive the vehicle.

21. The Operator is not responsible for contamination or damage resulting from outdoor parking.

22. The Operator does not check or register items left in the vehicle.

23. The Operator is not responsible for items left in the car, including phones, tablets, computers or navigation devices.

24. Explosives or flammable substances (except gasoline in the tank), living animals, biologically hazardous, perishable, toxic, radioactive or any other harmful substances are prohibited in the cars.

25. If there is a suspicion that any of the above-mentioned substances are in the car, the Operator will notify the authorities and follow their instructions.

26. The Operator does not assume any responsibility due to the violation of point 14, in such a case the Customer is responsible for any damages or claims.

27. If there is a dispute about the condition of the vehicle, the Customer is obliged to prove the deviation from the condition recorded by the Operator. The Customer bears all the costs of proof, even if he is proven right.

28. Fees: our current fees are available on our website.

29. The Client acknowledges that in case of failing to leave the parking lot until the end of the validity of the parking ticket, the vehicle will be removed at the Customer's expense, risk and liability. The liability of Sziget is excluded in this regard.

30. The Client acknowledges that he/she is only allowed to drive in the parking lot after the purchase of the voucher by online means. The voucher cannot be purchased at the entrance of the parking lot.

### Liablility of the Operator

31. In exchange for the current parking fee, the Operator keeps the parked vehicle in an outdoor parking facility.

32. Apart from following these regulations and trying to enforce them the Operator has no effect on other people's behaviour.

33. The Operator has no responsibility for any third party's behaviour, especially not for intended and inevitable damages, vandalism, theft or burglary done by them, regardless of their presence in the parking facility had been rightful or not.

Liability of the Customer

34. The Customer is obliged to pay all due fees and to follow the rules of these Parking Regulations.

35. The Client must have valid liability insurance for the car during whole period of parking. The Operator does not take over the car, its parts or accessories or possessions kept inside, so it is not responsible for any damages in them. The Client is aware of and accepts these facts when accepting the amount of the parking fee. The Operator does not accept liability for damages done by weather, natural disasters or any other conditions.
